The Gorham Town Board held a Regular Meeting and Public Hearing on February 13, 2019 at 7:00 pm at the Gorham Town Hall. Present were; Town Supervisor Frederick Lightfoote, Councilmembers; William Glitch, Brian S. Case, Richard Malcolm and Jake Chard. Water/Wastewater Chief Operator Greg Coston, Highway Superintendent Zach Eddinger, Zoning/Building Officer Gordy Freida, Deputy Zoning/Building Officer Jim Morse, Billing Clerk Brenda Jones and Town Clerk Darby Perrotte. Assessor Enza Mineo was necessarily absent. Other guests in attendance; Lynne Klotz, Brett Johnson, Emily Palumbos, Megan Webster, Sam Casella and George Barden.

1. Call to Order/Pledge to the Flag

2. Privilege of the Floor –

Ms. Megan Webster, from the Ontario County Soil and Water Conservation District, was present to speak in appreciation of Gordy Freida regarding his upcoming retirement.

Ms. Webster said "I have with me, Sam Casella our chairman, and George Barden the Watershed Inspector for the Canandaigua Lake Watershed Inspection Program. We just wanted to take this opportunity to recognize Gordy Freida for all his amazing supports and commitment to soil and water conservation and to the Watershed Commission and his general enthusiasm and good-naturedness."

Ms. Webster presented Mr. Freida with a Resolution of Appreciation from the Ontario Water and Soil Conservation District.

Mr. George Barden said "I have worked with Gordy for over twenty years. In dealing with a lot of the situations and projects, within the Canandaigua Lake Watershed portion of the Town of Gorham, it has been a pleasure to work with him in some of the most controversial projects. His cooperation and common sense approach to dealing with some of the people in the situations we've had to deal with it's been easy for me and it's made my job easier over the twenty years that he's been here and I wanted to thank him for that."

Mr. Sam Casella said "The main reason I came, because Megan and George could have carried this off very well, is similar to what George said. When I got elected in 1998 to the Town and I got on the council Gordy immediately became a stand out on the Commission. Whenever I felt I had a challenge or a problem or there was a bit of a controversy, George expressed it very well, one of the most stable, even-thinking people, I began to realize who that person was, it was Gordy. He knew what was going on, he knew this area and frankly, Gordy, you know people. You work well with people and you can communicate. I personally never saw him get rattled once. All those years I served, in those twelve years, Gordy was always the go to guy that kind of, in my opinion, sometimes kept the meeting together kept some composure going. He was someone I felt I could count on, talk to and get some counsel. With the benefit of his wisdom it helped me to make a better decision. Gordy was always the guy

that was right there for all of us, in this whole watershed and for all the people. Frankly, as people like Gordy retire and move on, I don't know if people really realize what they are losing with that kind of experience. There's nothing you can do about it, there's other young people coming up behind. As that happens in government you really pray that somebody comes up and picks up that baton and carries it as well as someone as seasoned and as experienced as Gordy. Gordy, it's been a pleasure working with you."

Supervisor Lightfoote said "I am so glad you could come and express this tonight. Your words are very well taken, it's great to hear other people say the same thing we have been saying for years. Thank you everyone."

RESOLUTION #4-2019

WHEREAS, the Town Board of the Town of Gorham is the governing body of the special districts and/or fire protection districts set forth in the Schedule attached hereto and made a part hereof; and

WHEREAS, it is the intent of this resolution to override the limit on the amount of real property taxes that may be levied by the Town of Gorham, on behalf of the aforesaid special districts and/or fire protection districts, pursuant to General Municipal Law §3-c, and to allow the Town of Gorham, on behalf of the aforesaid special districts and/or fire protection districts, to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c; and

WHEREAS, this resolution is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the tax levy limit for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Gorham, County of Ontario, is hereby authorized to adopt a budget for the fiscal year 2020 on behalf of the special districts and/or fire protection districts set forth in the Schedule attached hereto and made a part hereof that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Supervisor Lightfoote talked about starting an organic recycling program at the Transfer Station. A brief discussion was held. Supervisor Lightfoote tabled this until March to gather more information.

- 9. Privilege of the Floor –

Mrs. Lynn Klotz asked if the Board would be interested in having anyone from The Watershed Association talk briefly about the Blue/green algae problem in Canandaigua Lake. Councilmembers welcome a presentation from the Association. Mrs. Klotz will line up a representative for the next Town Board meeting March 13, 2019.

Mrs. Klotz said "The Association has put together a sub-committee. They came up with a plan called 'Healthy Lawns'. There's a little pledge card you can sign and it's specifically not binding and not very restrictive just some ideas on what homeowners can do to limit pesticide and herbicide use. The Association would like to get everybody in the Watershed to care more about the Lake but we're not sure how to do it."

Mrs. Klotz left a flyer the Association put together on how to protect our water quality. She is hoping we could send it out with the next Town newsletter.

Councilmember Glitch had a list of questions regarding old business.

Councilmember Glitch said "At some point we need to address the sidewalks regarding homeowners keeping them shoveled in front of their properties."

He asked how the accounting company was doing regarding payroll. Are there still mistakes with paychecks or is there a handle on it.

Supervisor Lightfoote said there have been changes made to the timesheets so that it is easier for the payroll company to understand them.

Councilmember Glitch asked about the disabled parking in the hamlet.

Supervisor Lightfoote said he is still waiting to hear back from the State.

The Board discussed the safety issues at the crosswalk near the elementary school.

Supervisor Lightfoote will talk to representatives from the State regarding fees to maintain flashing lights at the crosswalk.

Councilmember Glitch asked what is being done about the municipal parking lot not being used as Proctor's personal parking lot.

Deputy Zoning/Building Officer Morse said Gordy mentioned having a meeting with Proctor before the end of the month.

Councilmember Glitch asked about the water rates for the laundromat. He asked how many units the laundromat is being charged for.

Billing Clerk Jones said she could get those amounts for him.

Supervisor Lightfoote said Ms. Jones can gather the amounts and the Board can discuss it at next month's meeting.

Councilmember Glitch asked about the Watkin's property issues.

Supervisor Lightfoote said "The Town has exhausted anything more that we can do. It is in litigation."

10. Adjournment - with no further business, on the motion by Councilmember Chard, seconded by Councilmember Glitch the meeting was adjourned at 8:45pm. Motion carried unanimously. (5-0)
