3. Privilege of the Floor

Brett on NYSACC, now Chair of the Committee for Rural Community Outreach for NYSACC (cheers Brett) – goal to get more rural CAC (requires only 3 members)

- 4. Action Plan Reviews
  - a) Green Days 2024 (\$1250 est, ask Town to pay \$650-\$700 and Lynn will ask Greg H at MRB for half)
  - b) GCB Budget asked the Town Board to add \$2000 for our committee in the 2024 budget; unclear if it is approved; this money is to cover marketing, flyers, postage
  - c) ROW Biobags
    - i) Ben bought 100, 8 gallon biobags from Amazon for \$16 (donated); biodegradable, made with plant starch
    - ii) Darby has been giving them out and is asking for feedback
    - iii) Brian's contact \$37 for 1,000 (also 8 gallon)?
    - iv) Georganna looked at Costco for 8 gal, about same price as Ben's
    - v) Brett found bags \$1,306 for 6000 bags \$(5.15 or .16 per bag)
    - vi) Totes @ Impact Earth Easton Park still not picked up by 11/2/23 The ROW Program has 30 buckets left and 40 labels
- 5. Newsletter The last town newsletter went out in June 2023
