Supervisor Lightfoote was not feeling well and left the meeting at this time.

4. Public Hearing – 2024 Preliminary Budget.

The meeting and public hearing were duly advertised.

Councilmember Chard re-opened the public hearing.

Councilmember Chard apologized for the technical errors in getting the Preliminary Budget out to the public.

The Board discussed 2024 payroll projections.

Debbie North said she stated numerous times, considering the unneccsary cost thrown upon the town by the Highway Superintendent, between lawsuit settlement, \$30,000 roller, \$9,000 rental fees pigeonholed into the Easton Park instead of going through the proper channels because it was over \$6,000. Mrs. North stated he has not earned; he does not deserve a raise of any kind. She has not seen any benevolence of his time to jump in when he is needed to cover at the highway or transfer station.

Lynn Klotz, Lake Drive resident, stated the budget on the website is incomplete. She echoed Mrs. North's sentiment on payroll stating that the department that has cost taxpayers the most in irregular spending should not get cost of living increases.

Mrs. Klotz pointed out that sales tax revenue was up well above projections. Gorham can count on getting more money from Ontario County sales tax, that means less money that has to come out of the taxpayer's pocket on frivolous spending.

With no further comment, the hearing was closed.

The Board proceeded to go through the budget section by section with the following changes.

11/20/23 Privilege of the Floor Comments

In an email response from you, Fred, dated November 7th:

"As I have stated in the past, We don't have anyone in a "Highway Clerk 1" position. Not only that, we also don't have Highway Clerk 1 as a position allowed by Civil Service for use in the Town of Gorham. Brenda is still listed as Bookkeeper to the Supervisor because of other issues not at all connected to her. These are personnel issues that the Board is dealing with. There will be no discussion regarding this. Period."

To which I say "oh YES, we will discuss this!" I submit the following as reasons that your denial of my FOIL is wrong:

I FOIL'd the certified payroll for the town of Gorham. Brenda Jones is clearly noted as HIGHWAY SUPT CLERK 1 as of the payroll that you signed on 4/19/23 and for every subsequent payroll to date.

From the 10/11/23 Town Board meeting minutes as posted on the town website:

"Highway Superintendent Eddinger said he has been dealing with FEMA for the last month, it's been very tedious. He said he and the <u>Highway Clerk</u> have been spending anywhere from 3 to 4 hours a day, they are spending a lot of time with them doing paperwork."

As recent as the 11/15/23 special budget meeting at the town hall, payroll projections for the 2024 budget include under A5010.13 HIGHWAY CLERK BRENDA JONES \$4138.16 as part of her total compensation of \$42,055.79.

I would like you to honor my FOIL request for the official, dated job description for HIGHWAY SUPERINTENDENT CLERK. If you are unwilling or unable to fulfill my request, I will exercise my right as a resident to contact the New York State Comptroller's Office and ask them to start an investigation.

I believe that paying someone for a position that you claim doesn't exist but is clearly documented is perpetuating fraud on the taxpayers of Gorham.

Additionally, as Brenda Jones is being paid for a position that you say doesn't exist, I am demanding as a taxpayer that she immediately be terminated.

How much more will the incompetence of Zach Eddinger cost this town? We already have one lawsuit settlement due his and Brenda's ignorance. How much will the next one cost? Excessive, unapproved spending is another hallmark of Zach's tenure. I am again asking that he and Brenda NOT be given one more penny in compensation for 2024. And no, Brian Case, we aren't cutting Zach off at the knees as you suggested last week. We're asking for the nepotism and favoritism to end TONIGHT.

You, the entire board, are responsible to the taxpayers. You work for us. Do what is right!
